The present appeal dated 13.06.12 has been preferred by Shri Ashok Bhandary, hereinafter referred to as the Appellant, against the order bearing reference No. MRPL/HR/RTI/160/2012-13 dated 04.06.2012 of Shri P A Jose, CPIO, Mangalore Refinery and Petrochemical Limited, Mangalore - 575 030.

**Facts:**

1. Shri Ashok Bhandary, the applicant, *vide* application dated 25.5.12 sought the following information under the RTI Act, 2005 from the CPIO, MRPL:-
  - I. Details regarding agreed rates of contract for providing services per month.
  - II. Split figures of payments quoted by the service providing contractor, with details in respect of various heads.
  - III. Payment made by MRPL, in respect of all the months starting from September 2011, to the said contractor.
2. The CPIO, *vide* his/her letter bearing reference No. MRPL/HR/RTI/160/2012-13 dated 04.06.12. replied to the applicant as below:-
  1. Agreed rates of contract for providing services per month is Rs.6, 02,000/-.
  2. Attached as Annexure-A.
  3. Attached as Annexure-B.

3. Dissatisfied with the reply given by the CPIO, the Appellant has preferred the present appeal dated 13.06.12.
4. The Appellant, in his/her appeal dated 13.06.12, has stated, *inter alia*, the following grounds for preferring the present appeal:-

The Respondent has given information that agreed rates of contract for providing service per month is Rs.6, 02,000/-. The Respondent has not given information regarding the "split figures of payment quoted by the service providing contractor, with details in respect of various heads".

The information sought by the Appellant was regarding the split figures of above said Rs.6,02,000/-. The split figures under various heads such as (i) Basic, (ii) DA, (iii) Bonus, (iv) Conveyance, (v) Food Allowance (vi) PF, ESIC, (vii) MRPL special allowance (viii) Profit margin of the contractor etc. (as per the tender publication).


5. The Appellant prayed that the CPIO be directed to give the correct information to the Appellant as per his application dated 13.06.12.
6. The views/comments on the appeal were called for from the CPIO.

**Decision:** The information sought under Query (i) was "Details regarding agreed rates of contract for providing services per month", however what are the details sought was not specified in the query, hence CPIO has provided the available information, which is correct. The split up details required are specified only now in the appeal, i.e. basic, DA etc. As this amounts to a fresh query, the appellant, if required, may seek this information from CPIO, through a fresh query clearly specifying the information required.

7. The Appeal is disposed of accordingly.
8. A copy of this order is forwarded to the Appellant and the CPIO.

Hope this meets the requirement for the information sought.
