The present appeal dated 27.06.2013, received by AA on 03.07.2013 has been preferred by Shri Jitendra Sharma, hereinafter referred to as the Appellant, against the order bearing reference No MRPL./HR/RTI/257/2013-14 dated 30.05.2013 of Shri P A Jose, CPIO, MRPL Mangalore.

Facts:


1. Shri Jitendra Sharma, the applicant, *vide* application dated 26.04.2013 received by CPIO on 03.05.2013, sought 10 queries, seeking certain information on his application for employment in MRPL, under advt no.42/2012, under the RTI Act,2005 from the CPIO, Shri.P A Jose, HR Dept, MRPL, Mangalore.
2. The CPIO, *vide* his letter bearing reference No. MRPL./HR/RTI/257/2013-14 dated 30.05.2013 replied to the applicant, on all the 10 queries
3. Dissatisfied with the reply given by the CPIO, the Appellant has preferred the present appeal dated 27.06.2013.
4. The Appellant, in his appeal dated 27.06.2013, has stated, *inter alia*, the following grounds for preferring the present appeal :

- a. Question # 1 : It is requested to clarify the matter as information provided to me under RTI Act 2005 and the information available on the website is not matching, either information on the website or in writing provided to me is wrong.
 - b. Question # 2 : It is requested to provide the Xerox copies of marks allotted on question papers of written exam for better understanding and clarification.
 - c. Question # 3 : It is also requested to provide copies of marks allotted by interview panel to at the time of interview for better understanding and clarification.
5. The views/comments on the appeal were called for from the CPIO.

Decision:

1. The Appellant in his appeal dated 27.06.2013 has sought clarification on the information furnished by CPIO under Question # 1, 2 & 3 of his application dated 26.04.2013. Based on the review of the relevant documents, the decision/direction of the undersigned is as follows :
 - a. Question # 1 : It is clarified that the information provided to you is correct. Inadvertent error of erroneously showing admit card of sl.no.4 as 422012091330948, in place of 422012091331511 in the website is regretted and CPIO is directed to advise concerned to correct the same.
 - b. Question # 2 : Information sought is exempt from disclosure under section 8(i)d & 8(1)j.
 - c. Question # 3 : Information sought is exempt from disclosure under section 8(i)d & 8(1)j.
2. The Appeal is disposed of accordingly.
3. A copy of this order be forwarded to the Appellant and the CPIO.
