The present appeal dated 02.07.2013, received by AA on 04.07.2013 has been preferred by Shri M Pushparaj, hereinafter referred to as the Appellant, against the order bearing reference No MRPL./HR/RTI/260/2013-14 dated 06.06.2013 of Shri P A Jose, CPIO, MRPL Mangalore.


**Facts:**

1. Shri M Pushparaj, the applicant, *vide* application dated 04.05.2013 received by CPIO on 08.05.2013, sought certain information on Director (Finance) MRPL, under the RTI Act,2005 from the CPIO, Shri.P A Jose, HR Dept, MRPL, Mangalore.
2. The CPIO, *vide* his letter bearing reference No. MRPL./HR/RTI/260/2013-14 dated 06.06.2013 replied to the applicant, on all the 8 queries
3. Dissatisfied with the reply given by the CPIO, the Appellant has preferred the present appeal dated 02.07.2013.
4. The Appellant, in his/her appeal dated 15.06.2013, has stated, *inter alia*, the following grounds for preferring the present appeal :
  - a. Question # 3 : Proof asked in question has not been provided. Please attach salary slip of D(F) for the month March 2012 to March 2013.
  - b. Question # 4 : If MRPL guesthouse operated by Trust,
    - i. Whether Trust is managed by MRPL employees or by Private personnel ? If managed by MRPL employee please provide the name & designation of the employee managing the Trust.

- ii. Whether MRPL is spending any amount for running the Trust ? Who is auditing the accounts of the Trust ?
  - iii. Whether Guesthouse is the property of Trust or MRPL ?
  - iv. If Trust belongs to MRPL and managed by MRPL employee for MRPL employees, please provide the details of the amount paid by D(F) to Trust.
  - v. Whether it is permitted and authorized by Govt.of India to run such a Trust within MRPL premises ? If yes, please provide the copy of such government rule/order.
  - vi. Who is the authority for the Trust, to seek the information about the details of payment made by D(F) for boarding and lodging in the Guesthouse.
- c. Question # 6 : Purpose mentioned in Official tour but purpose of Official tour not provided. Please give details.
5. The views/comments on the appeal were called for from the CPIO.

**Decision:**

1. The Appellant in his appeal dated 02.07.2013 has stated that CPIO has not furnished the information sought under Question # 3, 4 & 6 of his application dated 04.05.2013. Based on the review of the relevant documents, the decision/direction of the undersigned is as follows :
  - a. Question # 3 : CPIO is hereby advised to provide salary slips or any other documents, showing payment of only the HRA for the period March 2012 to March 2013, within 10 days of receipt of this order.
  - a. Question # 4 : Appellant has sought additional information, arising out of reply given by CPIO, whereas CPIO has provided the information sought. Hence the decision of CPIO is upheld and in case the appellant is desirous of seeking this additional information, appellant is required to raise a fresh application.
  - b. Question # 6 : Decision/reply given by CPIO is upheld, as the information held by this public authority has been provided.
2. The Appeal is disposed of accordingly.
3. A copy of this order be forwarded to the Appellant and the CPIO.
